## **SEAPA Training Opportunity**

Southeast Alaska Pilots' is running a simulator exam April 24-28<sup>th</sup> with the written exam April 22<sup>nd</sup> 2023. This exam is open to new applicants that meet the minimum entry requirements. The application period will close Friday March 31<sup>st</sup>. Applications must be submitted electronically to seapa.training@gmail.com.

The cost of simulator time is expected to be approximately \$3,500 per applicant, payable to PMI. Note:

- (1) Absolutely no phone calls should be made to the SEAPA office. All questions should be directed to <a href="mailto:seapa.training@gmail.com">seapa.training@gmail.com</a>. Please check FAQ on our website before submitting a question.
- (2) When the application due date has passed, March 31st 2023, no new applications will be accepted.
- (3) All candidates MUST be able to qualify for a USCG First Class Pilotage endorsement without tonnage restriction. If the applicant has sea time that may be applicable (e.g. combined tug and tow) but does not currently hold an unlimited tonnage license, they will need to provide sea service of combined tonnage to qualify for First Class Pilotage without tonnage restriction.
- (4) Please note that no site visits are available due to COVID-19. All applicants will be given the site visit points.

## INSTRUCTION AND BACKGROUND INFORMATION

This information is provided to assist potential applicants in their understanding of the Southeast Alaska Pilots' Association (SEAPA) and the requirements for becoming a State of Alaska licensed marine pilot in Southeast Alaska.

SEAPA was established in 1971 and has its office in Ketchikan, Alaska. Our pilots are charged by the state to protect life, property, and the marine environment in Southeast Alaska. We typically pilot cruise ships, bulk cargo vessels, and large yachts. Cruise vessels comprise the vast majority of our

traffic. These ships are in the region from May through October, and accordingly all of our pilots work full-time through the summer.

SEAPA's region stretches from Dixon Entrance to Yakutat Bay, an area with 11,000 nautical miles of shoreline including National Parks, National Forest, National Monuments, and critical habitat areas. Southeast Alaska experiences large tides and tidal currents, dramatic weather with strong winds any time of year, and frequently reduced visibility. As with most of Alaska our working grounds are generally remote from civilization and support resources.

SEAPA pilots are independent contractors who operate in association to facilitate dispatch, safety, and efficiency in the provision of pilotage services. Pilots are responsible for their own business licensing and other expenses, retirement, and medical insurance.

Training for new pilots is arduous, beginning with the need to obtain a Federal pilotage endorsement for the entire region, passing State examinations, and completing over 100 supervised maneuvers. The training program is unfunded. Initial training takes between two and four years depending on the status of the trainee. An additional three years' experience as a Deputy Marine Pilot is required before becoming a fully licensed Marine Pilot.

It is extremely important that potential applicants ensure that they are eligible to obtain Federal Pilotage in Southeast Alaska. The specific requirements are spelled out in the pilotage package published by the USCG Officer in Charge of Marine Inspection, Southeast Alaska, which is available on the SEAPA website.

Pilotage in Alaska is governed by Alaska statute AS 08.62 and administrative code 12 AAC 56. Applicants are encouraged to review and familiarize themselves with these requirements, as well as the SEAPA training manuals available on this web page.

Applicants should pay close attention to the qualifying criteria and documentation requirements. Incomplete applications will be returned with a letter explaining the deficiencies. Applications will only be accepted on the SEAPA application form, including all required documentation and the application fee. All applications must be emailed on or before March 31<sup>st</sup>, 2023 to <a href="mailto:seapa.training@gmail.com">seapa.training@gmail.com</a>. Applicants are responsible for all costs associated with completion and submission of applications. An investigation of applicant background history will be conducted. The application fee of \$50.00 is for the processing of applications, background checks, experience verification, etcetera, and is non-refundable.

An applicant meeting the qualifying criteria will be informed of their status as a trainee candidate and be kept informed of details concerning the selection exams. **The agility test will be available at Concertra,** written examination, and bridge simulations will be conducted at Pacific Maritime Institute in Seattle, Washington. Potential candidates must be available during the entire week. The costs of the agility test and the simulation exams will be borne by the candidate, as well as travel expenses required to attend the exams. The actual cost for the simulation exam will be conveyed to the candidates once it is known how many people are taking the test.
